National Identity Management Solution

The Ministry of Information and Communications Technology (MoICT) is soliciting proposals from qualified international industry leaders to provide an on-premise Identity Management Solution as per the project description below.

Bidders interested in participating in this tender must enter in a Joint Venture agreement with a local Jordanian company specialized in implementing solutions of related area, or through their working offices in Jordan.

Interested Bidders are invited to visit the tendering department of MoICT starting from Tuesday 14/11/2017 to get the RFP copies according to the following:

1. Project Description:

The winning bidder should provide an on-premise solution to provide authentication when required in a secure way on behalf of the government entities. The solution should provide smart card support using identity management protocols in order to add an unprecedented level of security and convenience to services using these protocols. In addition to that, the solution will be responsible to provide digital signature as a service and Single Sign On functionalities, in addition to Mobile Authentication.

2. The cost of the tenders document is (450) JDs non-refundable.
3. Copies of the tenders documents can be purchased from the secretary of the Special Tendering Committee in MoICT starting from 10 o'clock Tuesday 14/11/2017.
4. Purchasing of tender documents must be done by an authorized representative of the bidder having a copy of the official authorization, and the representative must submit the following:
 - A certified official copy of the bidder's company registration including business registration & certificate of authorized personnel for signature in accordance with specified forms.
 - A letter from the international company authorizing the representative to purchase the tender documents.
 - Tender documents will only be sold if the above mentioned requirements are complete.
5. The last date for purchasing tender documents is on Tuesday, 21/11/2017 at 02:00 pm.
6. All inquiries should be addressed to MoICT at 22eGovt2017@moict.gov.jo by 28/11/2017. All inquiries will be responded to no later than 5/12/2017.
7. The proposal must be submitted as per the RFP terms and conditions in three envelopes, sealed separately and clearly marked:

- The first envelope to include 3 hard copies of the Technical and Corporate Capability Proposal (1 original and 2 copies) and 1 soft copy (CD) in addition to requested documents.
A certified company registration certificate must be attached with the provided technical proposal.
The Joint Venture Agreement signed by both parties.
 - The second envelope to include 3 hard copies of the Financial Proposal (1 original and 2 copies) and 1 soft copy (CD).
 - The third envelop must include the tender bond in the form of bank guarantee from a reputable registered bank, located in Jordan for the sum of (180,000) one hundred eighty Thousands Jordanian Dinars. The bond will be addressed in the name of His Excellency Minister of Information & Communications Technology in addition to his title, and must be valid for 90 days from the date of tender submission.
 - The tender bond of a joint venture can be in the name of one or more members participating in the joint venture submitting the proposal.
8. All envelops must be submitted to the Tendering Department/Special Tendering Committee Secretary, MoICT by an authorized representative of the Bidder. Proposals must be received strictly no later than 02:00PM on Tuesday, 26/12/2017.
 9. Technical proposals will be opened publicly at 02:30PM tentatively on Tuesday, 26/12/2017. After technical evaluation, only those bidders that qualify in the technical proposal will have their financial offers opened. The financial offers of those who do not qualify will be returned unopened.
 10. MoICT reserves the right to cancel this tender without giving reasons and without incurring any legal or financial liabilities or otherwise towards any of the bidders participating in the tender.
